**RANGE RULES, REGULATIONS & WAIVER OF LIABILITY FOR  
EMMETT & STONE COUNTRY SPORTS LTD AIRGUN RANGE,  
WILTON FARM, MARLOW ROAD, LITTLE MARLOW, BUCKINGHAMSHIRE, SL7 3RR

*Must be signed and followed by all who enter range to shoot*

**1. GUNS BROUGHT INTO THE RANGE:**

All air weapons brought into the range must be completely UNLOADED and cased. All air weapons need to be non-licensed sub 12 ft/lb.  
All guns and ammunition are subject to inspection by an EMMETT & STONE COUNTRY SPORTS LTD member of staff or range officer for cleanliness, workability and safety before entering the range.

**2. RANGE OFFICER:**

1. The Range Officer on duty is in direct charge of the range and all participants at all times.
2. The Range Officer will ban from the range any person handling an air weapon in an unsafe or careless manner. EMMETT & STONE COUNTRY SPORTS LTD may also void membership should such conduct warrant.

**3. FIRING POINT PROCEDURE:**

1. Only one loaded gun at a time. No other gun handling behind the firing point.
2. Make sure your hearing and eye protection is on *before* entering the range. Take position at the firing point assigned to you. **Do not** change firing points.
3. The **MUZZLE MUST BE POINTED DOWN RANGE AT ALL TIMES.**
4. Shooters must load and unload their own firearms. If a mechanical malfunction occurs, consult with the Range Officer or a member of the EMMETT & STONE COUNTRY SPORTS LTD member of staff.
5. Only line of sight firing is permitted. **(No drawing from the hip or holster.)** Keep your finger off the trigger until on target.
6. When leaving the firing point temporarily, lay the firearm with the muzzle down range and the action open and breach safety marker inserted.
7. Upon commencing and completion of shooting session, unload the air weapon with safety marker inserted and cased.
8. Cease firing means...STOP SHOOTING AND STEP BACK from firing point.
9. DO NOT REMOVE JAMMED OR MALFUNCTIONING FIREARMS away from the firing point; contact the Range Officer or EMMETT & STONE COUNTRY SPORTS LTD member of staff immediately for removal or assistance.

**4. VANDALISM:**

Any person seen firing at lights, baffles, carriers or any other range property or equipment will have their membership suspended, and will be reported to the proper authorities for appropriate action. Firing at boxes, cups, or other objects is prohibited. Only targets authorized by the Range Officer or an EMMETT & STONE COUNTRY SPORTS LTD member of staff will be permitted. All shooters will be held accountable and will pay for any damage you cause including replacement and installation charges.

**5. PERMISSABLE FIREARMS:**

1. Any sub 12 ft./lb air rifles and sub 6 ft./lb air pistols may be used on the EMMETT & STONE COUNTRY SPORTS LTD range.
2. All BB guns are allowed with permission of the Range Office or EMMETT & STONE COUNTRY SPORTS LTD member of staff.

**6. PERMISSABLE AMMUNITION:**

1. Standard commercial ammunition is permitted.
2. **No tracer, incendiary, armour piercing, gas or explosive ammunition permitted.**

**7. FIRING POINT OCCUPANTS:**

1. (All persons using the facilities shall be of good character and sound mind.) Appropriate dress is required at all times. EMMETT & STONE COUNTRY SPORTS LTD Range is a family oriented facility and we have the right to refuse service to anyone. Persons smelling of alcohol on their breath or who appears impaired will be required to leave the facility.
2. All persons utilizing the range are required to receive, understand and sign the rules, regulations and disclaimer and waiver of liability notice.
3. A responsible adult must accompany persons under twenty-one (21) years of age. This adult shall act as a coach, and **MUST** remain with the minor(s) at all times while the minor(s) utilizes the range.
4. **NO FOOD, DRINK OR SMOKING ALLOWED ON THE RANGE OR IN THE RANGE PREMISES.**
5. Only one shooter and coach permitted per firing point; only one un-cased firearm permitted at the firing point.
6. Persons not shooting or coaching are not permitted on the range.
7. No one is permitted forward of the firing line or onto the range at all. (NO EXCEPTION)
8. Any equipment or other personal items in/on a shooting lane left unattended are at the owner's risk. EMMETT & STONE COUNTRY SPORTS LTD is not responsible for lost or stolen items.

**8. EYE PROTECTION:**

1. Safety glasses are **STRONGLY RECOMMENDED** when entering the range. EMMETT & STONE COUNTRY SPORTS LTD rents safety glasses for a nominal fee or you may purchase from our inventory.

**9. HEARING PROTECTION:**

1. Hearing protection is **STRONGLY RECOMMENDED** when entering the range. EMMETT & STONE COUNTRY SPORTS LTD rents hearing protection for a nominal fee or you may purchase from our inventory.

PLEASE ASK THE RANGE OFFICER OR EMMETT & STONE COUNTRY SPORTS LTD MEMBER OF STAFF ABOUT ANYTHING YOU ARE NOT SURE OF. WE ARE HAPPY TO HELP IN ANYWAY WE CAN.
